1 ROLLER'S RELY Every responsibility of use and maintainance, in the period displayed above in the Rental Contract, is moved from LANGARENT Firma to the signatory of this Official Document. The Signer assume at his own risk, that all the duties belongs on him, in such time window. This document must be into the scooter for the whole time, being at disposal to whom it may concern at any time. Make sure to do a screenshot of this page, once is filled.

2 DRIVE AROUND There's no mileage limit in the Rent Tariff. Is not allowed to ride on Highways, identified with green signal plates. Alba, Asti , Barolo and Bra have already Limited Traffic Area (ZTL). The mentioned cities, have several gates in the downtown area controlled by cameras . The user must be aware to stay out and do not cross those forbidden sites on scooter. Please check pictures with samples of ZTL GATES in the back of this document.

3 CONDITIONS OF USE The Renter is committed to use the Vespa scooter after a self-supervision check of all the systems, if may suddenly notice any not correctly functioning, the user must immediately update the LANGARENT Firma about the failure appeared.

4 INSURANCE POLICY All the Vespas scooters Insurances are proof against any impact with cars, motorbikes, truck and third people. In case of accident ocured, do not sign any report of crash documents without the LANGARENT Firma permission. The accidental damages caused from carelessness are not included into the Rental Tariff. Who subscribe the Contract owe the duty of refund the broken parts/ bodywork refurbishment. Also, is warmly recommend to make Pictures and/or Videos of any scratches, dents, cracks or anything else does not look perfect on the scooter before the use.

5 EDGE OF RESPONSIBLY Every Vespa is provided in perfect conditions, with benefits like helmets and full tank. The LANGARENT Firma could not be held responsible about any damages, injuries, missed object of the user and/or third part in the whole rental period.
